

Overview of the Course

Management of Risk and Uncertainty (MoRU) is a two-day classroom-based course on identifying and managing risk. Developed and accredited by the Institute of Risk Management (IRM), the course raises awareness of risk management and explores the process, tools and techniques available for the successful assessment and treatment of risk.

It has been designed around the Risk Management Standard developed by IRM (with its UK partners AIRMIC and ALARM), which has been widely adopted throughout the world.

All delegates successfully completing a short assessment paper at the end of the course will receive a certificate testifying to their achievement from the IRM and Uncommon Solutions.

Being able to identify and manage risk is increasingly recognised as a critical leadership skill and a key element in corporate governance. However, few people in leadership roles have specific training in these skills. The MoRU training course is designed to address this need. It explores not only the risk management processes and techniques, but also the how to tie in with other business processes and how to embed a culture of risk management.

Course Content

The Course covers all aspects of general risk management and establishes a strong platform on which to build.

With extensive use of case studies and group exercises, the course maintains a very practical approach, with an emphasis on what can be taken away and applied in the workplace.

The content is divided into the following sessions over the two days:

Session 1 - Risk Management: emergence, scope and purpose

Session 2 - Risk assessment, analysis and evaluation

Session 2a - Risk perception and communication

Session 3 - Risk treatment – risk control

Session 3a - Business continuity planning: reducing the impact

Session 4 - Risk treatment – risk financing

Session 5 - Corporate governance, reporting, monitoring and embedding

Who should attend?

What is included (and what is not)

This is a two-day taught course, with official certification by IRM for successful completion.

A high quality and comprehensive delegate pack is included, with detailed workbook and additional study aids. Refreshments and lunch are included on each day, but the course is not residential, so overnight accommodation is not included. (If required, accommodation may normally be booked at discounted rates through the course venue – please ask for a booking code.)

All delegates will be given contact details to allow access to our post-training support services, for queries and problems relevant to the subject matter of the training. (There is no charge for this service and no time limit upon it, but we do reserve the right to let you know if we feel that enquiries are beginning to represent more than merely post-training support!)

In-House Courses

Where there are several delegates from the same organisation, it may be better to run the course on an 'in-house' basis, which we are happy to do. Significant discounts are available, as compared with the rates for public courses. An added benefit is that examples, case studies and terminology can be adapted better to reflect your own particular business area.
